BOARD OF TRUSTEES
APRIL 17, 2025
(PRESENTED FOR APPROVAL AT THE MEETING OF MAY 19, 2025)**

1. The Board of Trustees of the Township of Lyons held a Special Board Meeting on Thursday, April 17, 2025 in the Town Hall, 6404 Joliet Road, Countryside, Illinois 60525.
2. Supervisor Getty called the Meeting to order at 6:38 p.m.
3. Supervisor Getty stated that they will forego the Pledge of Allegiance for tonight's meeting.
4. Supervisor Getty asked for a motion to appoint Mary Van Allen from the Supervisor's Office to function as clerk Pro-Temp in the absence of Township of Lyons' Clerk Elyse Hoffenberg.
Trustee McDonald moved; Trustee Kelly seconded to appoint Mary Van Allen from the Supervisor's Office to function as clerk Pro-Temp in the absence of Township of Lyons' Clerk Elyse Hoffenberg.

5. Supervisor Getty called the Roll, and the following were present:

Also, in attendance was Patrick Hynes, Township of Lyons Highway Assessor; Lauren DaValle, Attorney with Odelson, Murphey, Frazier, & McGrath, Ltd. and Township resident Isabella Getty.

6. Supervisor Getty stated that the purpose of this Special Meeting of the Board of Trustees was to review the finances from the end of Fiscal Year 2024/2025 and to discuss the proposed budgets of the Township Offices and Departments for Fiscal Year 2025/2026 to be able to hang and publish the proposed budgets for 30 days hence and to schedule the Public Hearings on said Budgets.

7. Supervisor Getty stated that the budgets for the Township Offices and Departments for Fiscal Year 2025/2026 will remain essentially the same as the 2024/2025 Fiscal Year with only minor recommended changes being made after working within the predicted projections of incoming revenue given by the auditors. Supervisor Getty reported that revenue should increase by 2% next year due to an increase in overall taxes and that the only noticeable changes will be within the realm of payroll expenditures which will increase 5% across the board.

8. After a thorough review by the trustees, of the Tentative Budgets and Appropriation Ordinances presented, Trustee McDonald moved; Trustee Anderson seconded that the Tentative Budgets and Appropriation Ordinances be approved for Fiscal Year 2025/2026 and to direct the Clerk to publish the respective Tentative Budget Appropriation Ordinances in the local newspaper of record as directed by state statute and to hang the Proposed Budgets for the required thirty days after publication.
